Chapter 1 General Provisions

(Purpose)

- Article 1 The purpose of Nagasaki University (hereinafter, "University") is to provide education of the highest level with emphasis on practical training, to foster human resources who have a wide perspective, abundant culture and profound expertise and are rich in subject-exploring skills and creativity, and thereby to contribute to the regional and global society based on the philosophy set forth in Article 3 of the Basic Rules of the National University Corporation Nagasaki University (Rule No. 1 of 2004).
- 2 The duration of study, curricula, organizations for education and research, and other matters necessary for the learning of students in the faculties of the University shall

be governed by the provisions of these School Regulations.

(Publication, etc., of the Purposes of Educational and Research)

Article 1-2 The respective faculties shall define their purpose concerning the fostering of human resources and their other purposes of carrying out education and research for the respective faculties, departments or courses in their faculty regulations, etc., and publicize them.

(Faculties, Departments, Courses and Total Enrollment Capacity)

Article 2 The faculties of the University shall have the following departments and courses:

2 The total enrollment capacity shall be as specified in Appended Table 1. (Lectures, etc.)

Article 3 The Faculties and Departments listed in paragraph 1 of the preceding Article may have lectures, study subjects, etc.

2 Lectures, study subjects, etc., under the preceding paragraph shall be specified separately.

Chapter 2 Duration of Study, Period of Enrollment, School Year, Semester and Holidays

(Duration of Study)

Article 4 The duration of study for faculties shall be four years; provided, however, that the duration of study for the School of Medical Sciences of the School of Medicine, the School of Dentistry, and the Pharmacy of the School of Pharmaceutical Sciences shall be six years.

(Inclusion of study for persons who acquired certain number of credits before admission)

Article 5 In the cases where persons other than students of universities enter the University as credited auditors set forth in Article 61 or as credited auditors of special courses set forth in Article 63-2 after they have acquired the prescribed number of credits, and if they are deemed to have completed a part of the curricula of the University by the acquisition of such credits, the period determined by the President, taking the number of credits acquired and other matters into account after deliberation at the professors' meeting of the faculty in which the student is enrolled, can be included in the duration of study; provided, however, that such period shall not exceed one half of the duration of study.

(Enrollment Period)

Article 6 The enrollment period in the University shall not exceed twice the duration of study.

(School Year)

Article 7 A school year shall start on April 1 and end on March 31 of the following year.

(Semester)

Article 8 The school year shall be divided into the following two semesters:

First Semester: From April 1 to September 30

Second Semester: From October 1 to March 31 of the following year

- 2 Each of the semesters under the preceding paragraph may be divided into the first and second halves.
- 3 Notwithstanding the provision of paragraph 1, the President can change the semesters based on the circumstances of a faculty.

(Holidays)

Article 9 Holidays shall be as follows:

Sundays and Saturdays

Holidays prescribed by the National Holidays Act (Act No. 178 of 1948)

Commemoration Day for the Establishment of the University May 31

Spring Holidays From March 21 to April 7

Summer Holidays From August 11 to September 30

Winter Holidays From December 25 to January 7 of the following year

- 2 Notwithstanding the provisions of the preceding paragraph, the President may change holidays based on the circumstances of a faculty.
- 3 If the President deems it necessary, he/she can establish extraordinary holidays.

Chapter 3 Admission, Mid-course Entry, Transfer Entry, Transfer of Faculties, etc., Leave of Absence, Reiteration, Study Abroad, Withdrawal, Transfer to Another University, Readmission and Expulsion

(Time of Enrollment)

Article 10 The time of admission shall be the beginning of the school year; provided, however, that students can be admitted at the beginning of the second semester.

(Qualification for Admission)

- Article 11 Persons qualified for admission to the University shall be the persons falling under any of the following items:
 - (1) Persons who have graduated from a high school or a secondary school;
 - (2) Persons who have completed the school education of 12 years in ordinary curricula or persons who have completed similar school education in curricula other than the ordinary curricula;
 - (3) Persons who have completed the curricula of 12 years in school education in a foreign country, or other similar persons designated by the Minister of Education, Culture, Sports, Science and Technology;
 - (4) Persons who have completed the curricula of a foreign educational facility designated by the Minister of Education, Culture, Sports, Science and Technology as having curricula similar to that of a high school;
 - (5) Persons who have completed the advanced course of a special training school (which shall be limited to those whose duration of study is three years or longer and that meets other standards prescribed by said Minister) which is designated by said

Minister separately on or after the date prescribed by said Minister;

- (6) Persons who have been designated by said Minister;
- (7) Persons who have succeeded in the Certificate for Students Achieving the Proficiency Level of High School Graduates pursuant to the Rules on the Certificate for Students Achieving the Proficiency Level of High School Graduates (Ordinance of the Ministry of Education, Culture, Sports, Science and Technology No. 1 of 2005) (including persons who have succeeded in the University Entrance Qualification Examination pursuant to the Regulations on the University Entrance Qualification Examination [Ordinance of the Ministry of Education, Culture and Science No. 13 of 1951]) prior to the abolishment pursuant to the provisions of Article 2 of the Supplementary Provisions of said Rules;
- (8) Persons who have entered another university and who are evaluated by the University as having scholastic ability that deserves to receive education at the University pursuant to the provisions of paragraph 2 of Article 90 of the School Education Act (Act No. 26 of 1947);
- (9) Persons who are evaluated by separate examination by the University for qualification for admission to the University as having scholastic ability which is the same as or greater than that of graduates of a high school and who have reached 18 years of age;

(Procedures of Application for Enrollment)

Article 12 Applicants for admission shall apply in accordance with the prescribed procedures.

(Selective Examination)

Article 13 Applicants for admission shall receive selective examination in accordance with the provisions of the Rules on Selection for Nagasaki University (Rule No. 16 of 2004).

(Determination of Successful Applicants)

Article 14 The determination of successful applicants by the selective examination under the preceding Article shall be conducted by the President after deliberation of the professors' meeting of the respective faculties.

(Mid-course Entry to Faculties having Mid-course Entry Admission Capacity)

- Article 15 Persons who can be admitted in the third grade of the Faculty of Economics, the School of Health Sciences of the School of Medicine or the Faculty of Environmental Science shall be those who fall under any of the following items and have the qualification for application that is prescribed by the faculty in question, and they shall receive the selective examination, and the admission of entrants shall be permitted by the President after deliberation of the professors' meeting of the respective faculties.
 - (1) Persons who have graduated from a university;
 - (2) Persons to whom a bachelor's degree is conferred pursuant to the provisions of paragraph 7 of Article 104 of the School Education Act;
 - (3) Persons who have graduated from a junior college or an advanced professional training school or who are evaluated as having scholastic ability which is the same as or greater than that of graduates of such junior college or school;
 - (4) Persons who have completed a course of 14 years of school education in a foreign country;
 - (5) Persons who, by taking classes in Japan of education by correspondence provided by a school in a foreign country, have completed a course of 14 years of school education in a foreign country;
 - (6) Persons who have completed in Japan the course of an educational facility in a foreign country which is placed in the school education system of the foreign country as the one having the curricula of a junior college (which shall be limited to educational facilities whose graduates are deemed to have completed a course of 14 years of school education in the foreign country) and is designated by the Minister of Education, Culture, Sports, Science and Technology, Japan separately;
 - (7) Persons who have completed a professional course of a special training school (which shall be limited to courses whose duration of study is two years or longer and that meet other standards prescribed by said Minister) (who shall be limited to those who have the qualifications for admission set forth in Article 11); or
 - (8) Persons who have completed a high school education, the latter stage of a secondary school curriculum, or an advanced course of a school for children with special education needs (which shall be limited to courses whose duration of study

- is two years or longer and that meet other standards prescribed by said Minister) (who shall be limited to those who have the qualifications for admission set forth in Article 11).
- 2 Persons who can be admitted to the second grade of the School of Medical Sciences of the School of Medicine shall be those who fall under any of the following items and have the qualification for application that is prescribed by the faculty in question, and they shall receive a selective examination, and the admission of entrants shall be permitted by the President after deliberation of the professors' meeting of the respective faculties.
 - (1) Persons who have graduated from a university;
 - (2) Persons to whom a bachelor's degree is conferred pursuant to the provisions of paragraph 7 of Article 104 of the School Education Act;
 - (3) Persons who have completed a course of 16 years of school education in a foreign country;
 - (4) Persons who, by taking classes in Japan of education by correspondence provided by a school in a foreign country, have completed a course of 16 years of school education in a foreign country;
 - (5) Persons who have completed in Japan a course of an educational facility in a foreign country which is placed in the school education system of the foreign country as the one having the curricula of a university (which shall be limited to educational facilities whose graduates are deemed to have completed a course of 16 years of school education in the foreign country) and is designated by the Minister of Education, Culture, Sports, Science and Technology separately;
 - (6) Persons who have completed the professional course of a special training school (which shall be limited to those whose duration of study is four years or longer and that meets other standards prescribed by said Minister) which is designated by said Minister separately on or after the date prescribed by said Minister;

(Mid-course Entry and Transfer Entry in the Case of Vacancy)

Article 16 For persons falling under any of the following items, their admission can be permitted by the President after the selection and deliberation of the professors' meeting of the faculty only if there is a vacancy.

- (1) Persons to whom a bachelor's degree is conferred pursuant to the provisions of paragraph 7 of Article 104 of the School Education Act and who desire mid-course entry;
- (2) Persons who have graduated from a junior college, an advanced professional training school, the National Training Institute for Engineering Teachers, or the National Training Institute for Nursing Teachers, and who desire mid-course entry;
- (3) Persons who have completed a two-year course in the Faculty of Education or the Faculty of Liberal Arts or who have completed the curricula of the school pursuant to the regulations then in force set forth in Article 7 of the Supplementary Provisions of the Ordinance of Enforcement for the School Education Act (Ordinance of the Ministry of Education, Culture and Science No. 11 of 1947), or have graduated from such school and who desire mid-course entry;
- (4) Persons who have completed a course of 14 years in school education in a foreign country and who desire mid-course entry;
- (5) Persons who, by taking classes in Japan of education by correspondence provided by a school in a foreign country, have completed a course of 14 years of school education in a foreign country and who desire mid-course entry;
- (6) Persons who have completed in Japan the course of an educational facility in a foreign country which is placed in the school education system of the foreign country as one having the curricula of a junior college (which shall be limited to educational facilities whose graduates are deemed to have completed a course of 14 years of school education in the foreign country) and is designated by the Minister of Education, Culture, Sports, Science and Technology separately, and who desire mid-course entry;
- (7) Persons who have completed the professional course of a special training school (which shall be limited to those whose duration of study is two years or longer and that meets the other standards prescribed by said Minister) (who shall be limited to those who have the qualification for admission set forth in Article 11) and who desire mid-course entry;
- (8) Persons who have completed a high school education, the latter stage of a secondary school curriculum, or an advanced course of a school for children with

- special education needs (which shall be limited to courses whose duration of study is two years or longer and that meet other standards prescribed by said Minister) (who shall be limited to those who have the qualifications for admission set forth in Article 11), and who desire mid-course entry;
- (9) Persons who are enrolled in, have graduated from or have withdrawn from other universities and who desire mid-course entry; or
- (10) Persons who are in Japan and have enrolled in, have graduated from or have withdrawn from the course of an educational facility in a foreign country that is placed in the school education system of the foreign country as one having the curricula of a university and is designated by the Minister of Education, Culture, Sports, Science and Technology separately, and who desire mid-course entry (who shall be limited to those who have the qualification for admission set forth in Article 11).
- 2 In addition to the matters set forth in the respective items of the preceding paragraph, mid-course entry for persons who have completed the advancement course to medicine and dentistry or who are evaluated as having scholastic ability which is the same as or greater than that of the persons mentioned above shall be prescribed by the School of Medicine or the School of Dentistry separately.

 (Duration of Study, etc., of Persons for whom Mid-course Entry or Transfer Entry is Permitted)
- Article 17 For persons whose admission is permitted pursuant to the provisions of the preceding two Articles, credits acquired for class subjects that are taken prior to the admission, handling of learnings which are set forth in paragraph 1 of Article 37 and learned prior to the admission as well as the number of years the person is to be enrolled shall be prescribed by the President, after deliberation at the professors' meeting of the faculty in which the student is enrolled.
- 2 The total enrollment period of persons whose number of years to be enrolled is prescribed by the provisions of the preceding paragraph shall not exceed twice the number of years to be enrolled, notwithstanding the provisions of Article 6.
- 3 The period of leave of absence for persons whose number of years to be enrolled is prescribed by the provisions of paragraph 1 shall not exceed the number of years

equal to the number of years to be enrolled, notwithstanding the provisions of paragraph 2 of Article 22.

(Admission Procedures)

- Article 18 Persons who receive a notice of success for admission based on the results of an entrance examination or selection shall go through the following procedures on or before the designated date:
 - (1) Payment of the admission fee
 - (2) Submission of a written oath and a letter of guarantee; provided, however, that foreign students set forth in Article 64 shall only submit a written oath.
- 2 The guarantor in the letter of guarantee shall be a parent or similar person in principle and shall be responsible jointly and severally with the student. If any change occurs in the guarantor or his/her address, the student shall notify the University of such change promptly.

(Permission for Admission)

- Article 19 The President shall grant permission for admission to persons who have completed the admission procedures under the preceding Article (persons who apply for exemption or collection moratorium of the admission fee pursuant to the provisions of Article 53 shall be exempted from the procedure of item 1 of paragraph 1 of the preceding Article).
- 2 The President shall deliver a student ID card to persons to whom it grants the permission of admission at the time of their admission.
 (Transfer of Faculty, etc.)
- Article 20 If transfer of faculty is applied for by a student, the President may permit such application after deliberation at the professors' meeting of the concerned faculties.
- 2 The provisions of Article 17 shall apply mutatis mutandis to the duration of study, etc., of a person to whom the transfer of faculty is permitted pursuant to the provisions of the preceding paragraph.
- 3 The provisions of the preceding two paragraphs shall apply mutatis mutandis to changes of department or course. In this case, "professors' meeting of the concerned faculties" in paragraph 1 shall be deemed replaced with "professors' meeting of the

faculty in which the student is enrolled."

(Leave of Absence)

Article 21 If a student intends to suspend his/her learning for two months or longer continuously due to sickness or other reasons, the student shall apply for a leave of absence to the President by way of the Dean of the faculty in which the student is enrolled, and obtain the President's permission.

(Period of Leave of Absence)

- Article 22 The leave of absence shall not be longer than one year continuously; provided, however, that the President can permit a leave of absence for another one year in the case of a special reason.
- 2 The period of leave of absence shall not exceed four years in total (or six years in the cases of the School of Medical Sciences of the School of Medicine, the School of Dentistry, or Pharmacy of the School of Pharmaceutical Sciences).
- 3 The period of leave of absence shall not be counted in the period under Articles 6 and 45.

(Reinstatement)

Article 23 When the period of leave of absence expires or if the reason for the leave of absence expires or ceases to exist during the period of leave of absence, the student shall apply for a reinstatement to the President by way of the Dean of the faculty in which the student is enrolled, and obtain the President's permission.

(Study Abroad)

- Article 24 If the professors' meeting of the faculty in which the student is enrolled determines that the learning by a student in a university or junior college in a foreign country is effective from an educational standpoint, the President may, by arranging with said university or junior college in the foreign country, permit the student to go abroad for study at said university or junior college in the foreign country.
- 2 The period of the study abroad shall be counted in the period under Articles 6 and 45.

(Withdrawal)

Article 25 If a student intends to withdraw from the University, the student shall apply to the President by way of the Dean of the faculty in which the student is

enrolled and obtain the President's permission.

(Transfer to Another University)

Article 26 If a student intends to transfer to another university, the student shall apply to the President by way of the Dean of the faculty in which the student is enrolled and obtain the President's permission to receive the entrance examination. (Re-enrollment)

Article 27 If a person who has withdrawn pursuant to the provisions of Article 25 or a person who has been expelled pursuant to the provisions of Item 5 of the following Article applies for re-admission to a department or a course of the faculty in which he/she is enrolled before his/her withdrawal or expulsion within two years after the withdrawal or expulsion, the President may permit the re-admission after deliberation at the professors' meeting of the faculty in which the student is enrolled. In such cases, re-admission of a person who has been expelled pursuant to the provisions of Item 5 of the following Article shall be treated as reinstatement, and such reinstatement shall be subject to the payment of his or her outstanding tuition.

- 2 For persons whose re-admission is permitted pursuant to the provisions of the preceding paragraph, enrollment periods, periods of leave of absence, periods of study abroad and periods of suspension prior to withdrawal or expulsion from the University shall be counted into such periods after the re-admission, and the handling of credits acquired for class subjects already learned shall be decided by the President after deliberation at the professors' meeting of the faculty in which the student is enrolled.
- 3 If a reinstated person is expelled, such person will not be permitted to be reinstated again.

(Expulsion)

Article 28 If a student falls under any of the following items, the President shall expel such student after deliberation at the professors' meeting of the faculty in which the student is enrolled.

- (1) If the student fails to attend classes for a long time without justifiable reasons;
- (2) If it is determined that the student will not be able to live a decent campus life;
- (3) If the enrollment period exceeds the twice his/her duration of study, or if the

period of leave of absence exceeds the period set forth in paragraph 2 of Article 22;

- (4) If the student fails to apply for reinstatement even after the period of leave of absence expires.
- (5) If the student fails to pay the tuition;
- (6) If a student who has applied for exemption or collection moratorium of the admission fee pursuant to the provisions of Article 53 and falls under any of the following items fails to pay the admission fee to be paid on or before the designated date:
 - i) The exemption or collection moratorium is not approved;
 - ii) The exemption from a part of the admission fee is approved;
 - iii) The collection moratorium is approved.

Chapter 4 Organization of Curricula, Categories, etc., of Class Subjects, Credits,
Procedures for Taking Courses, Examination and Granting of Credits
(Organization of Curricula)

Article 29 The curricula shall be organized systematically by combining class subjects for general education which aims at having students acquire basic culture through the university education and learn wide-ranging bases for their specialty (hereinafter, "General Education Subjects") and class subjects for professional education associated with majors of faculties, etc. (hereinafter, "Professional Education Subjects") organically for the purpose of achieving the educational objectives of the University, faculties and departments or courses.

When organizing the curricula, the University shall give appropriate consideration to teaching students specialized in arts and sciences related to the majors offered by the faculties, etc., and at the same time to fostering a wide-ranging and in-depth general education and ability to make comprehensive judgments, and to cultivating a rich humanity.

(Category of Class Subjects)

Article 30 The categories of the General Education Subjects shall be as follows.

Culture seminar subject

Information science subject

Mathematical and data science subject

Health and sports science subject

Career education subject

Planetary health subject

Foreign language subject

Culture Module I subject

Culture Module II subject

Humanities and social sciences subject

Life and natural sciences subject

Integrated science subject

Global subject

Teacher training course-related subject

- 2 The category of Professional Education Subjects shall be as prescribed by the regulations of the respective faculties for taking classes (hereinafter, "Faculty Regulations").
- 3 If the University deems it necessary for the education of foreign students set forth in Article 64, and students other than foreign students who have received secondary education for an adequate period in foreign countries (which means education in schools corresponding to junior high schools or high schools) (hereinafter, "Foreign Students, etc." in this Chapter), the University shall establish subjects for foreign students in addition to the subjects set forth in paragraph 1.
- 4 All class subjects shall be divided into the categories of compulsory subjects, elective subjects and free elective subjects.

(Establishment of Class Subjects)

Article 31 The General Education Subjects shall be established with the participation of all the teachers of the University.

2 The Professional Education Subjects shall be established by the teachers of the respective faculties.

(Operating Method of Classes)

Article 32 Classes shall be conducted in the form of either lectures, seminars, experiments, or practical training and skills practice, or any combination thereof.

2 The University may have students study classes under the preceding paragraph by

- using a variety of media in a sophisticated manner and in places other than classrooms where the class subject in question is taken as prescribed by the Minister of Education, Culture, Sports, Science and Technology.
- 3 The University may have students study classes under paragraph 1 in foreign countries. The same rule shall apply to cases where the University has students study classes by using a variety of media in a sophisticated manner and in places other than classrooms where the class subject in question is taken.

(Class Hours for One Credit)

- Article 33 A class subject for one credit shall normally be organized to contain contents that require 45-hour learning, and class hours for one credit depending on the operating method of classes shall be based on the following standards:
 - (1) 15 hours for lectures
 - (2) 30 hours for seminars
 - (3) 45 hours for experiments, practical training and skills practice
- 2 If any circumstance makes it impossible to operate in accordance with the standard set forth in the preceding paragraph, or if it is necessary taking educational effect into account, the class hours for one credit can be determined by the Faculty Regulations or the Regulations on the General Education Learning of Nagasaki University (Regulation No. 2 of 2012; hereinafter, "Regulations on General Education Learning") within the scope of 15 to 30 hours in the case of lectures under item 1 and seminars under item 2 of the preceding paragraph and within the scope of 30 to 45 hours in the case of experiments, practical training and skills practice under item 3 of the preceding paragraph; provided, however, that regarding classes using two or more methods from among lectures, seminars, experiments, practical training, and skills practice, and private skills practice classes in the artistic fields, one credit can consist of classes conducted for a number of hours determined by the Faculty Regulations or the Regulations on General Education Learning.
- 3 Notwithstanding the provision of the preceding two paragraphs, regarding class subjects such as graduation theses, graduation research, and graduation products, when it is deemed to be appropriate to grant credits by evaluating the achievement of such learning, the number of credits can be determined in light of the learning, etc.,

necessary for these activities.

(Term of Classes)

Article 34 Classes of the respective class subjects shall be conducted within a period covering 8 weeks or 15 weeks or other appropriate periods as determined by the University as a unit in order to achieve sufficient educational effect.

(Indication, etc., of Achievement Result Evaluation Standards)

- Article 34-2 The respective faculties shall present a clear outline of the methodology used to give classes, the contents of classes, and a class schedule for the year to their students.
- 2 The respective faculties shall, when assessing their students' academic achievement and approving their graduation, present them with a clear outline of the standards therefor, in advance, so as to ensure objectivity and rigorousness, and shall conduct an assessment and approval process appropriately in accordance with said standards. (Organizational Training, etc., for Improving the Content of Education, etc.)
- Article 34-3 The respective faculties shall conduct organized training and research for improving the contents and methodology used to give classes at said faculties.

 (Taking of Class Subjects, etc., at Other Faculties)
- Article 35 If a faculty determines that it is effective for its student to take class subjects of other faculties from an educational standpoint, the faculty may have the student take the class subject in question.
- 2 If a student intends to take a class subject established by another faculty, the student shall obtain the approval of the Dean of the faculty that has the class subject in question by way of the Dean of the faculty in which he/she is enrolled.
- 3 The handling of credits acquired by the student for the class subject taken by him/her pursuant to the provisions of the preceding two paragraphs shall be prescribed by the Faculty Regulations.

(Taking of Class Subjects, etc., at Graduate Schools of the University)

Article 35-2 If a student desires to advance to the Graduate School of the University, and if a faculty determines that it is effective for the student to take class subjects of the Graduate School in question from an educational standpoint, the faculty may have the student take the class subject in question.

- 2 If a student intends to take a class subject established by the Graduate School of the University, the student shall obtain the approval of the Dean of the Graduate School or the Dean of the Interfaculty Initiative that has the class subject in question by way of the Dean of the faculty in which he/she is enrolled.
- 3 Credits acquired by the student for the class subject taken by him/her pursuant to the provisions of paragraphs 1 shall not be included in the number of credits to be acquired by students that is prescribed in the Faculty Regulations as a requirement for graduation from the faculty in which he/she is enrolled (hereinafter, "Graduation Requirement Credits").

(Taking of Class Subjects, etc., at Other Universities or Junior Colleges)

- Article 36 If a faculty determines that it is effective for its student to take class subjects of another university or junior college from an educational standpoint, the faculty shall consult with the other university or junior college in question in advance, shall approve the student to take the class subjects of the other university or junior college in question, and may regard credits acquired by the student by completing class subjects as credits acquired by completing class subjects of the University to an extent not exceeding 60 credits.
- The provisions of the preceding paragraph shall apply mutatis mutandis to cases where a student goes abroad for study pursuant to the provisions of Article 24, where a student takes class subjects conducted by a university or a junior college in a foreign country during his/her period of leave of absence, where a student takes class subjects conducted by a foreign university or a junior college by correspondence education in Japan, and where a student takes class subjects in Japan that are conducted by a foreign educational facility positioned as an facility that has the curricula of a university or junior college under said foreign country's school education system and as designated separately by the Minister of Education, Culture, Sports, Science and Technology.

(Learning at Educational Facilities, etc., Other than Universities)

Article 37 The University may, when deeming it to be effective from an educational standpoint, deem its student's learning at a junior college, learning of an advanced course at a college of technology, or other learning specified separately by the

- Minister of Education, Culture, Sports, Science and Technology to be his/her learning of class subjects at the University, and grant credits.
- 2 The number of credits that the University may grant in accordance with the preceding paragraph shall not exceed 60 credits, together with the number of credits deemed to have been acquired at the University under the provisions of the preceding Article.

(Approval of Credits Acquired Prior to Admission)

- Article 38 If a student has the following credits prior to admission to the University, and if the University deems it effective from an educational standpoint, the University may regard such credits as those that he/she has acquired by completing class subjects at the University after the admission.
 - (1) Credits that are acquired for class subjects that the student has completed in a university or junior college (including universities or junior colleges in foreign countries)
 - (2) Credits that are acquired as credited auditors set forth in paragraph 1 of Article 31 of the Standards for the Establishment of a University (Ordinance of the Ministry of Education, Science and Culture No. 28 of 1956)
 - (3) Credits that are acquired as credited auditors of special courses set forth in paragraph 2 of Article 31 of the Standards for the Establishment of a University
- 2 The University may, when deeming it effective from an educational standpoint, regard its student's learning prior to being admitted to the University as prescribed in paragraph (1) of the preceding Article to be his/her learning of class subjects at the University, and grant credits therefor.
- 3 The number of credits other than those acquired at the University, which may be deemed to have been acquired or which may be granted as prescribed in the preceding two paragraphs, shall not exceed 60 credits, together with the number of credits deemed to have been acquired at the University under paragraph 1 of Article 36 and paragraph 1 of the preceding Article, except in cases of mid-course entry and transfers, etc.

(Completion of Curricula in the Longer Term)

Article 39 The University may, when a student has applied for his/her wish to

complete the curricula for graduation over a certain period of time exceeding the duration of study set forth in Article 4 in a planned manner, due to such circumstances as his/her having an occupation, approve his/her planned completion of the curricula, as prescribed in the Regulations on Long Term Completion of Curricula of Nagasaki University (Regulation No. 47 of 2006).

(Handling of Credits for Foreign Student Subjects for Foreign Students, etc.)

Article 40 Credits acquired by Foreign Students, etc., for foreign student subjects may be replaced with credits to be acquired as General Education Subjects, as prescribed in the Regulations on General Education Learning.

(Upper Limit for Registration of Classes)

- Article 41 With regard to the number of credits to be acquired as graduation requirements, the University may fix an upper limit to the number of credits for which its students can register for a year or for a term in the Faculty Regulations, so that they can take class subjects appropriately for each school year.
- 2 In the case of the preceding paragraph, the University may approve students who have acquired all the predetermined credits with excellent results to register for class subjects over the upper limit prescribed in the preceding paragraph, as prescribed in the Faculty Regulations.

(Examination and Granting of Credits)

- Article 42 If a student has completed a class subject, the student shall be examined, and credit shall be granted to the student if he/she passes.
- 2 The examination shall be conducted by test, thesis, reports or other methods.
- Article 43 The examination and approval of credits shall be governed by the provisions of the Faculty Regulations or the Regulations on General Education Learning.

 (Method of Taking Classes, etc.)
- Article 44 In addition to the matters prescribed in this Chapter, the organization of curricula, the names of class subjects, the numbers of credits, the methods of taking classes, the upper limit for registration of subjects to be taken, the examination and granting of credits, and so on shall be governed by the provisions of the Faculty Regulations and the Regulations on General Education Learning.

Chapter 5 Acquisition of Required Qualifications for Graduation and Degrees as

well as for the Conferral of a Teacher's License (Graduation and Conferral of a Degree)

- Article 45 With regard to persons who have been enrolled in the University for a period set forth in Article 4 (or, in the case of persons whose admission is permitted pursuant to the provisions of Articles 15 and 16, the number of years for which such persons are required to be enrolled as prescribed in paragraph 1 of Article 17) or longer and who have acquired the Graduation Requirement Credits, the President shall approve the graduation after deliberation at the professors' meeting of the faculty in which the person is enrolled and shall confer a bachelor's degree; provided, however, that if the respective faculties deem it necessary, they may impose requirements for graduation in addition to the enrollment period and the Graduation Requirement Credits.
- 2 Out of the Graduation Requirement Credits, the number of credits that may be acquired by the operating method of classes set forth in paragraph 2 of Article 32 shall not exceed 60 credits, unless otherwise set forth.
- Article 46 If it is determined that persons who have been enrolled in faculties (excluding the School of Medical Sciences of the School of Medicine, the School of Dentistry, and the Pharmacy of the School of Pharmaceutical Sciences; the same applies in this Article) for three years or longer (including persons who are prescribed by the Minister of Education, Culture, Sports, Science and Technology as being similar to those mentioned above) have acquired the Graduation Requirement Credits with excellent results, the President may approve their graduation notwithstanding the provisions of Article 4.
- 2 The approval of graduation set forth in the preceding paragraph shall be conducted only if all of the following requirements are satisfied:
 - (1) The person in question is a student of a faculty that specifies the standard for assessing students' academic achievement and other standards for graduation as set forth in the preceding paragraph and publishes them.
 - (2) The person in question is a student of a faculty that specifies the upper limit of the number of credits that can be registered as class subjects as set forth in Article 41, and implements said limit properly.

- (3) It is determined that a student has acquired the Graduation Requirement Credits and he/she acquired such credits with excellent results.
- (4) A student desires graduation as set forth in the preceding paragraph.
- Article 47 The conferral of degrees, etc., shall be governed by the provisions of the Rules on Degrees of Nagasaki University (Rule No. 11 of 2004).

(Acquisition of Required Qualifications for a Teacher's License)

- Article 48 Persons who have acquired the necessary credits in departments, etc., of the respective faculties of the University as set forth in the Act on the License of Teachers (Act No. 147 of 1949) and the Ordinance for Enforcement of the Act on the License of Teachers (Ordinance of the Ministry of Education, Science and Culture No. 26 of 1954) shall be entitled to acquire the required qualifications for the conferral of a teacher's license.
- 2 The category of teacher's licenses for which the required qualifications can be acquired pursuant to the provisions of the preceding paragraph shall be as stated in Appended Table 2.

Chapter 6 Awards and Punishments

(Awards and Punishments)

- Article 49 If a person engages in any act that deserves honor as a student, the President may give an award to such person based on the recommendation of the Dean of the faculty, etc., in which the person is enrolled.
- Article 50 If a person violates the rules of the University, disturbs the order of the University or otherwise engages in any act that is contrary to the duty of a student, the President shall punish said person after deliberation at the Education and Research Council of Nagasaki University.
- 2 The punishment shall consist of expulsion, suspension and admonishment.
- 3 The suspension shall include a definite suspension with a fixed term and an indefinite suspension without a fixed term.
- 4 If a period of suspension exceeds one month, the period shall be counted in the period under Article 6 and shall not be counted in the period in which a student is required to be enrolled as a requirement for graduation under Articles 45 and 46.

Chapter 7 Entrance Examination Fees, Admission Fees, Tuition and Dormitory

Charges

(Entrance Examination Fee)

Article 51 A person who applies for admission, transfer entry, mid-course entry or re-admission shall pay the entrance examination fee.

(Amount of Entrance Examination Fee, etc., and Method of Collection thereof, etc.)

Article 52 The amounts of the entrance examination fee, admission fee and tuition, and the collection method thereof, etc., shall be governed by, in addition to the matters prescribed in these School Regulations, the provisions of the Regulations on the Collection of Tuition, Admission Fees, Entrance Examination Fees and Dormitory Charges for Nagasaki University (Regulation No. 92 of 2004; hereinafter, "Collection Regulations").

(Exemption and Collection Moratorium of Admission Fee)

Article 53 With regard to a person whom the University considers to have seriously difficulty in paying the admission fee due to a special circumstance, the University may exempt or grant a moratorium of collection of the admission fee, in whole or in part, based on the application by the person.

2 The exemption and collection moratorium of the admission fee shall be governed by the provisions of the Regulations on Exemption, etc., of the Admission Fees, Tuition and Dormitory Charges for Nagasaki University (Regulation No. 93 of 2004; hereinafter, "Exemption Regulations").

(Payment Period of Tuition)

Article 54 The tuition shall be divided into two portions—that for the first semester and that for the second semester—and shall be paid in the amount equal to one half of the yearly amount for each semester respectively during the period prescribed below:

For the first semester from April 1 to April 30

For the second semester from October 1 to October 30

- 2 Notwithstanding the provisions of the preceding paragraph, when a student pays the tuition for the first semester, he/she can also pay the tuition for the second semester at the same time.
- 3 Notwithstanding the provisions of paragraph 1, a student can pay the tuition for the first semester or for the first and second semesters of the admission year when his/her

admission is permitted.

(Exemption and Collection Moratorium of Tuition)

- Article 55 With regard to a student who is considered as having difficulty in paying the tuition for economic reasons and being excellent in his/her scholastic ability, or a student who is considered as having unavoidable circumstances, the University may examine such student's circumstances and exempt or grant a collection moratorium of the tuition in whole or in part based on his/her application.
- 2 The exemption and collection moratorium of the tuition under the preceding paragraph shall be governed by, in addition to the matters prescribed in these School Regulations, the provisions of the Exemption Regulations.
- Article 56 The time limit of the collection moratorium for the tuition set forth in the preceding Article shall expire on September 15 for the first semester and on March 15 for the second semester.
- Article 57 Persons for whom a leave of absence is permitted during the payment time set forth in Article 54 shall be exempted from the tuition for the period from a month following the month in which the leave of absence starts to the previous month of the month of reinstatement; provided, however, that if the period of leave of absence starts on the first day of a month, said persons shall also be exempted from the tuition for the month, and if the starting day of the second semester is before October 1 pursuant to the provisions of paragraph 3 of Article 8 and paragraph 2 of Article 9 and the day of reinstatement is the starting day of the second semester in question, said persons shall also be exempted from the tuition for the month of reinstatement.
- Article 58 With regard to persons who withdraw, transfer to another university, or receive an order of suspension or expulsion, the tuition for the semester shall be collected, except for cases where the provisions of the Exemption Regulations apply. (Dormitory Charge)
- Article 59 The amount of dormitory charge and the collection method thereof, etc., shall be governed by the Collection Regulations.
- 2 If a student has a special circumstance, the dormitory charge may be exempted.
- 3 The exemption of the dormitory charge shall be governed by the Exemption Regulations.

(Refund of Charge and Fees)

Article 60 Already paid charges and fees shall not be refunded; provided, however, that if any of the following items is applicable, the amount equal to the charges and fees in question (in the case of item 2, the amount of the entrance examination fee for the second step set forth in item 1; and in the case of item 4, the amount equal to the tuition for the second semester) shall be refunded.

- (1) In the entrance examination, selection by application documents, etc., is conducted (hereinafter, "First Step Selection"), and then selection by scholastic ability test, etc., is conducted only for successful applicants of the First Step Selection (hereinafter, "Second Step Selection") to determine the finally successful applicants, if an unsuccessful applicant of the First Step Selection applies for a refund of the entrance examination fee for the Second Step Selection on or before the designated date;
- (2) A person who knows that he/she is not qualified for the entrance examination of the University as he/she has not received a test on lessons or subjects of the unified university entrance exam that are imposed by the respective faculties after they have accepted application for the first schedule or the second schedule of the individual scholastic ability test (hereinafter, "First Schedule Test or Second Schedule Test") applies for a refund of the entrance examination fee for the First Schedule Test or the Second Schedule Test on or before the designated date;
- (3) A person who has paid the tuition pursuant to the provisions of paragraph 3 of Article 54 when his/her admission is permitted declines his/her admission and applies for a refund of the tuition on or before March 31 of the fiscal year prior to the fiscal year of the admission;
- (4) A person who also paid the tuition for the second semester when he/she paid the tuition for the first semester pursuant to the provisions of paragraph 2 or 3 of Article 54 enters his/her leave of absence or withdraws prior to the payment time of the tuition for the second semester;

Chapter 8 Credited Auditors, Postgraduates, Special Auditing Students, Special Courses and Foreign Students

(Credited Auditors)

Article 61 If persons who are not students of respective faculties desire to take a class subject or class subjects established by the University, the University may admit them as credited auditors after the selection.

(Postgraduates)

Article 62 If persons desire to carry out a research on a special matter at the University, the University may admit them as postgraduates after the selection. (Special Auditing Students)

Article 63 If students of another university or junior college (including universities or junior colleges in foreign countries) desire to take a specified class subject of the University, the University may admit such students as special auditing students based on consultation with the other university or junior college in question.

- 2 The entrance examination fee and the enrollment fee for special auditing students shall not be collected.
- 3 The tuition for special auditing students shall be the same as for credited auditors.
- 4 Notwithstanding the provisions of the preceding paragraph, if a special auditing student is a student of a foreign university or junior college that is a party to an academic exchange agreement, etc. or of a university or junior college that is a party to an inter-university agreement for mutual exchange of credits, either of which prescribes that the tuition shall not be collected from special auditing students, the tuition shall not be collected.
- 5 Already paid tuition shall not be refunded.
- 6 The actual cost required for experiments and practical training shall be borne by the special auditing students, if necessary.

(Special Course)

Article 63-2 The President may organize a special course for persons who are not students of the University, and deliver a certificate certifying the fact of completion to persons who have completed said special course.

- 2 In the case where the granting of credits for a special course set forth in the preceding paragraph is announced publicly in advance, credits can be granted to persons who have completed said special course.
- 3 If the President determines that it is effective from an educational standpoint for

students of the University to take said special course set forth in paragraph 1, the President may have them take said special course.

(Foreign Students)

Article 64 If a person desires to be admitted to the University as a foreign student, the University may admit such person after the selection.

(Regulations)

Article 65 Regulations on details concerning Article 61 to the preceding Article shall be prescribed separately.

Chapter 9 Miscellaneous Provisions

(Dormitory)

Article 66 The University shall have a dormitory or dormitories.

2 Rules on the dormitories shall be prescribed separately.

(Health)

Article 66-2 Students shall receive a health check conducted by the University in each school year.

2 The Dean of faculties in which students are enrolled shall manage their health and order them to receive medical treatment if necessary or may order them not to come to the campus.

(Additional Provisions)

Article 67 Matters necessary to enforce these School Regulations shall be prescribed by the President, and the regulations necessary for the respective faculties shall be prescribed by the respective Deans after the approval of the President is obtained.

Supplementary Provisions

- 1 These School Regulations shall come into effect as of April 1, 2004.
- 2 The School Regulations for Nagasaki University (which was established on May 31, 1949) shall be repealed.
- 3 With regard to persons who are enrolled in the University as of March 31, 2004 (hereinafter referred to as "Incumbent Enrolled Persons" in this paragraph) and persons who are admitted by mid-course entry, transfer entry or re-enrollment on and after April 1, 2004 in the grade in which the Incumbent Enrolled Persons are enrolled, the old School Regulations for Nagasaki University shall still be valid after the

enforcement of these School Regulations.

- 4 The admission capacity for the fiscal year 2024 shall be 115 for the School of Medical Sciences, School of Medicine, 231 for the School of Medicine, and 1,636 for the respective faculties in total, notwithstanding the provisions of Appended Table 1.
- 5 The enrollment capacity of the School of Medicine for the fiscal years from 2024 to 2029 shall be as follows, notwithstanding the provisions in the column of the School of

Medicine in Appended Table 1.
